“NOT A RED SNAPPER” TOURNAMENT RULES

1. All participants must attend the Safety Meeting (MAY 4th. @ 6:30 pm)
2. All snapper must be **speared** by divers, while diving.....no line caught snapper.
3. All participants must hold a **valid Florida fishing license**
4. All snapper **MUST** be within legal limits set by the FWC.
5. No participant shall take more than **the legal limit of fish**
6. Weigh-in will be from 4:00 pm-5:30 pm (**held at Dive Locker**)
7. In the event of a tie, 1st snapper weighed-in, wins
8. Weigh Master/Tournament Director has the final say (no appeal)
9. If participant is on the property by 5:30 pm, snapper will be weighed
10. Snapper taken on the same boat may be pooled for BIG FOUR category
11. Each snapper can be weighed in only 1 category
12. All snapper weighed in become the property of the **Dive Locker**
13. Tournament starts at midnight after the safety meeting.
14. All participants must be **Certified Scuba Divers and must stay within their certification limits**
15. Only 1 entry per category for participant
16. All participants **MUST HAVE FUN!!!!** So please **NO CHEATING!!!**
17. Black, Cubera, Mangrove, Grey, Mutton, Vermillion and all other legal Snapper, **EXCLUDING** Red Snapper are fair game.
18. Absolutely **NO RED SNAPPER !!!!**

COMPLETE LIABILITY RELEASE AND INDEMNITY AGREEMENT

I understand the purpose of signing this document is to exempt and release dive locker of Panama City Beach, Its employees and agents and to hold these entities harmless from any and all liabilities arising as a consequence of the following or any other acts or omissions.

I have received scuba diving and snorkeling instruction from a nationally recognized diving certification agency and have made at least five (5) open water dives. I understand that there are inherent risks and dangers associated with scuba diving and snorkeling, including but not limited to, risks associated with equipment failure, perils of the sea and acts of fellow divers.

I acknowledge that I am physically fit to scuba dive and I will not hold any of the above named responsible if I am injured as a result of any illness, heart, lung or any other medical problem which might occur while diving/snorkeling.

I do not have in my possession any illegal drugs, nor am I taking or have I taken any drugs or medications that would impair my ability to scuba dive or snorkel.

Prior to leaving the dock I will personally inspect all equipment to be used and I will not use any defective equipment.

I will be present at and attentive to the safety briefing given by the tournament director and if there is anything I do not understand or have been taught differently, I will notify the director immediately.

I understand that I have a duty to plan and carry out my own dive and to be responsible for my own safety and for the safety of my dive buddy.

I will follow safe diving practices at all times and agree not to exceed the depth of 130 feet and to stay well within "No Decompression" limits during the tournament.

I will start my ascent at the end of each dive with enough air to guarantee being on the boat with a minimum of 500 PSI remaining in my tank.

I will immediately stop my dive if;

I feel uncomfortable with my diving abilities; and/or
Diving conditions are worse than those for which I have experience.

I am aware of the dangers of holding my breath while diving and the dangers associated with rapid ascent.
